Request to change the designation of the Reliability Coordinator of Québec
(File R-3996-2016 Phase 2)

Objet of the request

On December 21, 2016, Hydro-Québec (the "**Applicant**") filed a request to the Régie de l'énergie (the "**Régie**") regarding the designation of the Reliability Coordinator of Québec (the "**Designation**") as well as the Reliability Standards' consultation process in the context of a future ongoing docket before the Régie.

The application is submitted under section 31 (5°) and 85.5 of the Act respecting the *Régie de l'énergie* (the **Act**).

The application and the related documents are available on the Régie's website at www.regie-energie.qc.ca and at its offices.

Phase 2 application review procedure

By its decision D-2017-077, the Régie sets the timeline for reviewing Phase 2 and convenes a public hearing. Phase 2 will focus on the designation of the Reliability Coordinator in Québec, the reassessment of the reliability model that was established in Québec, and of the model in relation to the Québec Reliability Coordinator as designated by the Régie in its decisions D-2007-95 (file R-3625-2007), D-2010-106 (file R-3728-2010), D-2011-132 (file R-3771-2011) and D-2017-033 (Phase 1 of the present filing).

The Régie invites those persons interested in Phase 2 to submit an application for intervention and a participation budget in accordance with the requirements of the *Regulation respecting the procedure of the Régie de l'énergie* and the *Costs Payment Guide (2012)* on or before **October 13, 2017 at 12 p.m.** Specifically, any interested person wishing to participate in the study of this file must demonstrate their direct interest in the matter. They must also indicate the subjects that they intend to address, their relevance to the analysis of the file by the Régie, and their impact on the persons it represents, if any. The Applicant may comment on these requests in writing no later than **October 20, 2017 at 12 p.m.** Any reply by a party of the Applicant's comments must be provided no later than **October 25, 2017 at 12 p.m.**

The Régie will specify additional procedures for processing this application at a later date.
